21/141	Apologies for absence.	RESOLVED that the apologies received from Councillors Peter Foley, Angie Miller and Tim Wright be accepted and noted.

21/145	Matters of Urgency.	RESOLVED that it be noted that there were no matters of urgency to be considered by the Council.
21/146	Public Participation.	<p>The Chair asked the parishioners present if they wished to make any contributions relating to any items on the agenda, or any other parish related matter which they may wish to raise. The Parish Council also discussed issues that parishioners had been in contact about.</p> <ol style="list-style-type: none"> 1. A parishioner has enquired about why Story Homes has not handed over the management group to the residents of The Meadows as had been their intention.

2. A parishioner has raised concerns about a tree that needs checking out to make sure it is safe. It is situated on Parish Council land next to the wall at Bankfoot.
3. A parishioner has informed the Parish Council that they keep getting harassed for parking a car on the bus stop opposite the village hall, although they do not have a car. Councillor Chris West has spoken to the parishioner and the issue is now resolved.
4. A parishioner attended the meeting to speak on their concerns about Planning Application 21/0583 which was to be considered later on in the meeting. They were concerned that the addition of the large timber-framed windows was not in keeping with the rest of the village, especially in an area of traditional stone buildings. They stated that it did not comply with the Lazonby Neighbourhood Plan Design Statement. They were also concerned that the two dwellings did not sit on the same line as the other houses in that area. The parishioner wanted a site meeting to take place and for the application to go to the Eden District Council planning committee.
5. A parishioner has complained about the state of the footpaths in the village and the holes appearing in them, as well as the issue of dropped kerbs for wheelchair users. It was suggested that an onsite meeting was held to see the issues. There is a new system of reporting these issues to Cumbria Highways.
6. The hedge is encroaching over the public footpath on Main Street again and obscuring the view of the traffic.
7. There have been complaints regarding a dog walking service that appears to be walking up to seven dogs at one time usually down at the River Eden in Lazonby. The complaints have mainly been about out of control dogs who are frightening people as well as dog fouling.
8. Complaints have been made by parishioners about dog fouling near Scarrows Lane. Dog wardens visited and placed a few posters about keeping dogs on a lead and picking up after their dogs. They also stencilled in 2/3 specific locations identified by the resident. They then received a call to say that the stencils had been painted over with an unknown substance and the sticker(s) on the bin were also vandalised (although they had then been re-stuck by a dog walker). The stencil spray they use is temporary, safe to the environment and animals and designed to last a few weeks or so as it is chalk based. The resident was concerned about what has been used to 'paint over it'. They then re-stencilled for a second time and placed more posters where they had been pulled down, but it appears the same has happened once again and was removed by someone. The Community Wardens said they would think as to whether they should try for a third time as replacing posters, in particular, is costly. They asked if the Parish Council had any other information that might shed light on this.
9. A parishioner has kindly given the Parish Council some information covering issues relating to sustainable transport and affordable housing in Lazonby which he was asked to share following a conversation with one of the Parish Councillors doing a leaflet drop about the Egg Packing Station affordable housing project.

	<p>a. Proposed Development of Lazonby Egg Packing Station.</p>	<p>The Council received an update about the Egg Packing Station Housing Project. A flyer with all the updates on the Egg Packing Station Housing Project has now been circulated within the local community. The Outline planning application for up to seven affordable houses has been submitted to Eden District Council Planning Services. The planning application will establish what can be built on the site, deal with the flood, contamination etc..issues regarding building on the site and also establish the final purchase price. The Parish Council have given the Vendors a provisional price for the site but are still waiting for a response from the vendors who have hired a Land Agent to do their own assessment. A parishioner has given a list of comments about what the site could be made into as an alternative to the housing. However, this may not receive the funding needed and the value of the land could be an issue.</p> <p>RESOLVED that a note of thanks be made to those who helped deliver the leaflets update about the Egg Packing Station Housing Project.</p> <p>ALSO RESOLVED that Councillor Gordon Nicolson is happy to speak to the parishioner regarding their comments and suggestions for the egg packing station site.</p> <p>ALSO RESOLVED that the Parish Council wished to thank the parishioner for their comments which was noted.</p> <p>ALSO RESOLVED that Councillors Chris West and Peter Foley be thanked for the report about the Egg Packing Station Housing Project which was noted.</p>

	<p>b. Environmental projects for the Parish.</p>	<p>The Parish Council considered the possible environmental projects in the parish and potential funding streams. The Clerk put an article in the Parish Council Newsletter to say that the Parish Council were looking at funding for environmental projects in the parish, so if anyone had any suggestions on what the Parish Council could do to contact the Clerk and their suggestions would be passed onto the Parish Council. The Parish Council would then look into whether the suggested projects would fit the funding criteria of the funding that they were looking into.</p> <p>A parishioner has also given some suggestions for an environmental project to find funding for which entailed environmental improvements in the vicinity of railway bridge no. 306 as it crosses the B6413. The land has been kept as clean as possible by kind volunteers who have routinely cleared nettles, brambles and other intrusive vegetation causing inconvenience to pedestrians, wheelchair users and school children. However, the land does not belong to the Parish Council but instead Network rail. It was suggested that the Parish Council could ask Network rail if they could clear the area and possible re-landscape it.</p> <p>There are three emerging projects on Green Recovery, which include the opportunity to secure funding under the Government's Nature for Climate Fund and the National Lottery Green Recovery Challenge Fund. The two that would fit the parish the best would be the Local Authority Treescapes Fund (LATF) and the Green Recovery Challenge Fund - Pollinator for Plants. A possible project would be the hedgerow along the road edge between Eden Bridge and the Swimming Pool. The other possible project could be to put in a pollinators hedge at Will Pool.</p>
		<p>RESOLVED that the Parish Council thank the Parishioner for their suggestions for an environmental project which was noted.</p> <p>ALSO RESOLVED that the Clerk report the land in the vicinity of railway bridge no. 306 to Network rail and ask them if they could clear the land and possibly re-landscape it to make it look better.</p> <p>ALSO RESOLVED that Councillors Hilary Carrick, Phillip Whitehead and Chris West have an on-site visit at Will Pool to look at possibly planting a pollinator's hedge as part of the projects for the environment.</p> <p>ALSO RESOLVED that the Clerk resend the environmental funding information to all Councillors again so that they can look at possible projects.</p>

21/158	Planning Application 20/0904 (Genesis Homes) Scaur Lane, Lazonby.	<p>The Council considered how to proceed with Planning Application 20/0904, the Genesis Homes development on Scaur Lane. Eden District Council Planning Services has been in contact with the Parish Council to apologise for not having been able to take this application for the Genesis Homes development on Scaur Lane forward to a determination as yet. They explained that Genesis Homes and Planning Services had agreed to look into making some revisions to the scheme, and will of course re-consult with the parish Council when they have received new plans. In the meantime, if the changes result in an improved scheme could they ask if the Parish Council's request for the application to be determined by Committee be reconsidered. This is because Planning Services have not got a definitive objection from the Parish, and the developer would like to avoid the potential for a Committee decision to go against them. The Clerk gave the Parish Council this information via email.</p> <p>Then the Parish Council were contacted again with the following information from the Land Director of Genesis Homes who asked if the Parish Council could consider his response, and in particular point 7 below regarding the Committee call-in; and if there is anything further the Parish Council would like to raise then please let him know:</p> <p><i>“Further to my earlier email, please see my response to the queries raised by the Parish.</i></p> <p><i>The Outline application (17/0016) was for residential development with access, this was not number specific. Subsequently, Cumbrian Homes submitted a reserved matters application (18/0420) for 50no. homes.</i></p> <p><i>Although not related to the Cumbrian application, the increase in property numbers is due to the inclusion of additional smaller 3 bed properties that would suit first time buyers and young families. While we have proposed an increase in the number of properties, the density has in fact decreased. Accounting for the reduction in site area from 25,772sqm to 21,316sqm, on a pro-rata basis the approved Cumbrian scheme accommodated 61,565sqft on the reduced area, the Genesis proposal is for 60,813sqft.</i></p> <p><i>It is also worth noting that we have increased the Public Open Space from the previously approved Cumbrian scheme by 1,339sqm.</i></p>

		<p><i>As above, I believe it is important to consider the density of the development rather than the number of properties. Our wider offering in terms of product mix brings numerous benefits to the community that would not have been seen in previous approvals.</i></p> <p><i>We will be providing a 30% affordable contribution and an education contribution of £266,066 for the additional primary and secondary places as per the existing S.106. Procedurally it is not possible to request additional contributions at the reserved matters stage. I would however be happy to discuss separately, but this would be outside the planning process.</i></p> <p><i>We are amending our boundary treatment plan to incorporate a sandstone wall along the site frontage rather than brick as per the PCs comments. In addition, the heads and sills for the properties mentioned will be stone.</i></p> <p><i>We have added electric vehicle charging to 30% of the properties (17) and a plan illustrating this will be issued shortly. The street lighting will be dealt with under the S38 / 278 applications.</i></p> <p><i>I hope the above answers the PCs outstanding queries and offers additional confidence in the areas they felt our application was lacking. If the Parish could remove its request for this application to go to committee, this would be welcomed - please can you confirm? This would allow us to progress the potential of providing the affordable scheme on the other site previously discussed.”</i></p> <p>RESOLVED that the Council agreed that planning application 20/0904, the Genesis Homes development on Scaur Lane, did not need to go to the Planning Committee as all the issues that the Parish Council had raised had been addressed.</p> <p>ALSO RESOLVED that the Parish Council would like to discuss further with Genesis Homes the offer of additional funding towards projects in the parish.</p>
