Councillor Tim Wright reported that the School are happy to be part of the event. The Swimming Pool Committee are also happy to be a part of the event. The date for the event is Saturday 8th October 2022. There will be lots of apple-related activities. If it is successful this could be an annual Autumn event.</p>

		RESOLVED that Councillors Tim Wright and Andrew Miller are meeting with the North Cumbria Orchard Group (NCOG) to discuss the event further, and they will also talk to the School children about the event too.
22/147	Report from District Councillor Gordon Nicolson.	<p>The Council received a report from District Councillor Gordon Nicolson about Eden District Council matters affecting the Parish.</p> <ol style="list-style-type: none"> 1. Local Government Organisation – there is a lot of work behind the scenes with several project groups looking at several work streams. It is hoped to be a seamless transfer from old to new Councils with services still being delivered as normal. Service contracts have been extended for the transitional period beyond April 2023. The conclusions from all working groups will be given to the Shadow Authority for approval. It is more challenging for the new Councils to determine the way ahead for current services such as Adult Social care, Children’s Services and Education. Options are being considered. However, the Fire and Rescue Service will be maintained as a single Cumbria wide service. The Police and Crime Commissioner have submitted a bid to Government to make the Fire and Rescue Service his responsibility. A response is awaited but some Councillors and the Fire Brigade Union oppose this proposal. 2. Eden District Council’s Review Group for the Transfer of Assets has now reached its final decisions which were stated on the July 2022 agenda and consequently on these minutes at minute 22/157. 3. A task and finish group is considering the extent to which Section 106 Agreement obligations have been met by developers and others. These are legally binding agreements attached to planning approval and typically cover the provision of affordable housing issues, contributions to education services and health care. <p>RESOLVED that District Councillor Gordon Nicolson be thanked for his report, the contents of which were noted.</p> <p>ALSO RESOLVED that it be noted that District Councillor Gordon Nicolson reserved the right to request to speak on other issues on the agenda.</p>
22/148	Report from County Councillor Hilary Carrick.	<p>The Council received a report from County Councillor Hilary Carrick about County Council matters affecting the Parish.</p> <ol style="list-style-type: none"> 1. The County Council is very busy with the transitional arrangements for the transfer of their current responsibilities to the new authority as well as trying to maintain business as usual. 2. Recruitment to the key officer posts has started with the recruitment of the Chief Executive for the Westmorland and Furness Council. The closing date for applications was Monday 4th July 2022 and the council received 17 applications. Once a Chief Executive has been appointed, recruitment will start for the other statutory posts of the Monitoring Officer and the Section 151 Finance Officer. 3. Discussions are ongoing about the way services could be delivered in future with blueprints being produced. The final decisions on these, however, will lie with the new Council from Vesting day, 1st April 2023. <p>RESOLVED that County Councillor Hilary Carrick be thanked for her report, the contents of which were noted.</p>

LDNPA press release: National Park Authority is looking for hidden gems to celebrate local heritage - The National Park Authority is inviting residents and visitors to highlight the special buildings, sites and features that make the Lake District special and should be celebrated. A new campaign, designed to help protect the 'commonplace or everyday' heritage assets that are valued by people locally, but don't have any existing protection in their own right under planning law is now living in the Lake District. As part of this, a new Local Heritage List is being compiled and anyone can help protect and celebrate a wide range of heritage features by nominating them for inclusion. All nominations will be considered by a panel made up of council and voluntary heritage group representatives from across Cumbria and all successful sites will be added to the Local Heritage List which will be available to search online. 2. He believes the Bill gives me the chance to change Cumbria for the better if they can force the government to listen. He explained that although our local communities are wonderful places to live and work they are at risk due to a lack of affordable homes, unreliable public transport and a lack of well-paid jobs. Being on this committee gives him the best opportunity to do something about this. In the Levelling Up Bill, the government is not currently going to properly address those

		<p>problems - but by being part of this Committee, Tim Farron MP will have the chance to propose amendments to make sure that they do. He aims to ask the government to help the communities in Cumbria. He would therefore be really grateful to hear any thoughts and ideas Parish Council's may have about how Cumbria can be "levelled up" with the rest of the country. This will greatly help him put forward amendments to the Bill in this committee.</p> <p>3. NALC Dementia Survey - NALCs new survey on dementia-friendly councils. The survey closes on the 22nd of July 2022.</p> <p>4. Emergency Information Sheet for Town and Parish Councils - There are around 50 towns and parishes across Cumbria that have an emergency plan in place, led by a community response group within the area.
