23/135	Public Participation.	<p>As there was no parishioners present the Parish Council discussed issues that parishioners had been in contact about.</p> <ol style="list-style-type: none"> 1. The Lorries delivering etc. to the new housing development have been turning down Scaur Lane past the village hall from the Main Street but they have been told that they should enter Scaur Lane via the Great Salkeld road end. All the Hauliers have been told of this but from now on the instructions will be put on the delivery notes to remind the drivers. However, parishioners have to remember there

		<p>will still be some Lorries entering from the Village Hall end of Scour Lane who deliver goods to houses on Meadow Close, Scour Close, Scour Lane and Barton Dale who have nothing to do with the new housing development.</p> <ol style="list-style-type: none"> 2. The existing rubbish bin at the swimming pool has been filling up to overflowing on a regular basis, so much so Councillors Chris West has had to empty it on one occasion. 3. A parishioner has asked if Swift bird boxes can be put up around the village.

23/137	Report from the local Community Police.	<p>The Council received a report from the local Community Police for June 2023.</p> <ol style="list-style-type: none"> 1. Suspicious incident- At 00:30hrs on 12/06 a Silver Suzuki Vitara was parked on the side of the road on the Kirkoswald side of the bridge, torches could be seen and voices heard in the river by the swimming pool. There was a 'clatter' up, ducks disturbed and men could be seen running in the river. 2. 04/06- Youths in the river by Eden Lacy (Lacy Caves side), one got into trouble in the water, police attended and male casualty was lying on the floor on the opposite side, Police officer swam across the river and walked casualty to nearest ambulance where the youth was taken to hospital as they needed stitches to a tear caused by high pressure rapids. 3. Shoplifting- At 17:40hrs on 07/06, a male has entered Lazonby Co-Op and stolen £400 worth of medication from the shelves.

Parish Fishing (Last minute 23/117).</p>	<p>The Council received progress reports regarding matters from the Minutes of the Council Meeting on the 7th June 2023.</p> <p>RESOLVED that there was nothing further to report at present on the donations at Eden Bridge car park.</p> <p>RESOLVED that it be noted that there was nothing further to report on the program for the maintenance of footpaths, including drop kerbs.</p> <p>ALSO RESOLVED that Councillors Andrew Miller and Tim Wright will redo the original survey on the state of the footpath due to their worsening state.</p> <p>The Council received an update about the Fishing Rights and Bailiffing in the parish. At the last meeting of the Parish Council in June 2023, the following concerns were raised which were discussed again because of some confusion over the points being raised.</p> <ol style="list-style-type: none"> 1. How did the Anglers Club derive the sum of of £1750. Also has the free fishing for under 16's and the discounted fees for OAP's been taken into consideration. 2. Educating the local parishioners to apply for an annual free permit will need time and may not be received well for being onerous. 3. It would be difficult to enforce a daily limit to the tickets sold because the volunteers working at both the Kirkoswald shop and the Swimming Pool may not remember to relay the information to each other. 4. A review would be needed to calculate, daytime, evening and OAP rates, and would the commission be kept by the agents for the three daily permits? 5. This needs time to investigate, and to consult local parishioners who fish the river. So maybe signing up this year is too soon? 6. Are parishioners who casually fish without permits going to have issues with the fishing bailiffs? <p>Councillor Peter Foley did not understand why the proposals were not OK and having been absent from the last Parish Council meeting in June was surprised about the decision to have a meeting between himself, Tim Wright, the Treasurer to the Council Chris Hoy and a local Angler from the parish to brainstorm all the issues that need to be resolved about the fishing rights</p>

		<p>because he felt that the report and work he had already carried out covered most issues. The Council discussed the above points including speaking to local fisherman, levelling out the budget and looking at a review date.</p> <p>RESOLVED that Councillor Peter Foley be given delegated authority to continue to progress the project with the Angling Club to iron out any concerns and issues, and liaise with the Council via email during the summer break.</p> <p>ALSO RESOLVED that Councillors Chris West and Peter Foley will speak to a local Angler to gauge their views on the proposals that will affect at local level.</p>
	d. Mud on Road from Quarry Vehicles and Blocked Gulley (Last minute 23/117).	RESOLVED that the repairs on the blocked gulley are still ongoing.
	e. Lazonby Parish Council Grants for 2023 – 2024 Update (Last minute 23/112).	<p>The Council received an update on the Lazonby Festive Tree Club grant. At the last meeting the Treasurer reported that the grant that was awarded to Lazonby Festive Tree Club had not been given to the applicants because although they were written to twice requesting their bank details to pay the grant, they did not reply so the Treasurer was not able to pay them. At the June 2023 meeting of the Parish Council it was agreed that Councillor Tim Wright would speak to the Lazonby Festive Tree Club and ask them to submit a letter refusing the grant for the parish Council records, as it was deemed that it was not needed by them now due to a change of circumstances for the project. Councillor Tim Wright has spoken to them and they apologise for not being in touch sooner. Furthermore, the pub is now under new management so the project could go ahead.</p> <p>RESOLVED that the Treasurer Chris Hoy write to the Lazonby Festive Tree Club to accept their apologies for not being in touch sooner, to inform they would need to reapply again on the next round of Parish Council grants, that it could only be funded as a one off project and that they need to provide their bank details if they want to receive a grant in the future.</p>
23/140	Report from the Westmorland & Furness Councillor.	<p>The Council received a written report from Westmoreland & Furness Councillor Hilary Carrick about Westmorland & Furness matters affecting the Parish.</p> <p>General Issues</p> <p>1. Westmorland and Furness Council have now been in existence for 3 months and are starting to gain traction. The Eden Locality Board has only met once formally but has held three seminars to discuss the physical, social and economic aspects of each ward and identify the top priority issues. As a consequence it is proposed that the main priorities for the Eden Locality Board are:</p> <ul style="list-style-type: none"> • Priority 1. To ensure that Eden is a great area to grow up where children are happy, healthy and have opportunities to reach their full potential. • Priority 2. To better connect our places by maintaining and developing our networks, infrastructure links and modes of travel. • Priority 3. To empower our communities to thrive by supporting a strength and asset based approach to healthy

		<p>lifestyles and wellbeing.</p> <ul style="list-style-type: none"> • Priority 4. To consider the challenge of climate change and biodiversity in everything the Board does. <p>These will be discussed and agreed at the Eden Locality Board meeting on Monday 10 July 2023. There were a number of common themes throughout the district including access to services, training and jobs, highways, young people’s mental health and rural isolation, but also pride in our local environment.</p> <p>2. At the beginning of August Councillor Hilary Carrick will be ‘Walking the Ward’ with the Highways Network Manager to give him a flavour of local highways concerns. Councillor Carrick will raise the issue of the potholes on our roads and the state of our footways on your behalf but if there are any other issues you would like Councillor Hilary Carrick to highlight, could you please let her know before the end of the month, preferably in a co-ordinated way via Councillor Chris West and the Clerk to the Parish Council.</p> <p>Local Issues</p> <p>1. Councillor Hilary Carrick has reported the damage surrounding the manhole outside the Co-op to highways as a trip hazard. Responsibility for the repair to this manhole lies with United Utilities but Highways have contacted them on our behalf.</p> <p>2. As the Parish Council will remember that the issue of heavy construction vehicles accessing or departing the Genesis site has been raised before, particularly in respect of damage being done to the pavement and drain cover at the corner by the Village Hall. The background is that unfortunately Eden District Council did not apply any conditions to the outline planning application 17/0740 relating to the routing plans for the construction traffic and so in the later discharge of conditions for application 22/0088 no details have been provided for the routes for the construction traffic. Highways have since contacted Genesis directly to request that large construction vehicles avoid using the junction by the Village Hall. Councillor Hilary Carrick would be grateful if those of you who live nearer the site can monitor this on her behalf so that she can report back any difficulties.</p> <p>3. Councillor Hilary Carrick is currently in pursuit of some facts regarding the funding for the egg packing station project. The decision regarding the approval of grant funding for the project does not need to be approved by Cabinet and can be approved by officers from Westmorland and Furness Council.</p> <p>RESOLVED that Westmoreland & Furness Councillor Hilary Carrick be thanked for her report, the contents of which were noted.</p>

Also to revisit the Parish Council's tree survey; get the school involved in projects; and look into the pollinator pledge.

4. Can your Parish Council Pledge to make Positive Change for pollinators? Paul Evans, the Cumbria Local Nature Partnership Manager, has written to say:

*“The Cumbria Local Nature Partnership has recently produced **Cumbria’s Plan Bee** - A Pollinator Action (see [Cumbria Plan Bee | Saving our pollinators | Cumbria Wildlife Trust](#)). The plan urges everyone in the county – communities, the new local authorities and other councils, farmers, landowners and businesses – to sign a pledge [Cumbria Plan Bee | Make a pledge | Cumbria Wildlife Trust](#) and take action to help Cumbria’s pollinating insects wild bees, butterflies, hoverflies and moths play a vital role in our food production and are a key part of our natural world. However, many species are in trouble due to habitat loss, pesticide exposure, disease and climate change. Cumbria’s Plan Bee sets out how we can start to reverse this trend together. It identifies no fewer than 66 priority actions to help our pollinating insects. These range from small acts (e.g. building a bee hotel in your garden) to larger-scale measures, such as councils making the most of opportunities in new and existing developments to make them pollinator-friendly, everyone reducing pesticide use and farmers creating more wildflower-rich areas. To make a difference we need to get everyone thinking about pollinators, everyone taking some action (however small) and to get every available piece of land working for pollinators. We know that if everyone can do something to help our native pollinators, even if something very small, we will make a big difference and give our bees, hoverflies, butterflies and moths a better future. And of course if we help these ‘small things’ it will have benefits not only to us (by helping to pollinate our vegetable and fruit crops) but also a wide range of birds, mammals and other animals. We hope your Parish or Town Council will discuss what they can do to help and then make a pledge (see above) to make a positive change for pollinators. In addition we would ask that you encourage members of your community, local schools and other organisations/businesses to also make a pledge. Together we can make a real difference.”*

5. Pot Hole Emergency - Parish Council Highways Briefing Event - Eden, South Lakes and Barrow District Associations are delighted to invite you to this free virtual forum with Westmorland and Furness Highways Team on Wednesday the 19th of July 2023 at 6.45pm for a 7.00pm prompt start. Westmorland and Furness Council is responsible for maintaining 2,700 miles of principal and minor roads. A multi-million pound programme to tackle potholes, blocked gullies and other road repair and maintenance issues has recently been agreed by Westmorland and Furness Council. Their crews are currently using three jet patching machines each capable of making up to 150 permanent pothole repairs per day. Join fellow Eden, South Lakes and Barrow members, alongside colleagues from
